Application Process

This funding opportunity is open to mobility advocacy groups that have not received a Mobility Fund grant in the past and who are seeking support to continue critical operations in collaboration with priority community groups, peers, and partners.

The grant program supports community-based advocacy around sustainable and equitable mobility and seeks to: (1) support ongoing essential advocacy group operations; (2) increase access to and use of active transportation modes and public transit; and (3) foster cost and time saving collaborations.

Mobility advocate groups interested in this funding opportunity will compete this Letter of Interest Form by July 15, 2021. Applicants best aligned with this fund's goals will be invited to submit full proposals using the a short form sent with their invitation. Full proposals are due by October 20, 2021.

Definitions:

- 1. Mobility Advocate Group: For the purpose of this RFP, a mobility advocate group is an organization of individuals within a community that amplify residents' voices on the need for expanded transit, biking, walking and land use that enables people to thrive without depending on an automobile. These groups must have a legal designation or be fiscally sponsored by an organization with a legal designation like a nonprofit, B-corporation, social enterprise, or a public benefits corporation.
- 2. Priority Community Group: Group(s) made up of and/or serving people who are impacted by systems of oppression and injustice, economic disadvantage, environmental harm, and climate vulnerability. Note: A priority community group can be represented by an individual organization, multiple organizations, and/or individual community members who have worked in service to and have hence established a deep level of trust with the priority community group(s).
